SUBJECT: Approve an amendment to Agreement 24129 with Visalia Unified School District.

REQUEST(S):

That the Board of Supervisors:

1. Approve an amendment to Agreement 24129 with Visalia Unified School District to provide instructional services to Tulare County inmates, from July 1, 2011 through June 30, 2012.
2. Authorize the Chairman of the Board to sign three copies of the Agreement.

SUMMARY:

The Sheriff's Department has been contracting with Visalia Unified School District since June 30, 1994, to provide instructional services to inmates. A new agreement was approved by the Board on July 7, 2009 and amended again on July 20, 2010. This amendment is the second amendment to the original agreement. Classes currently being provided by Visalia Unified School District include General Equivalency Diploma (GED), Job Skills, Life Skills, and English Language Development (ELD). In 2010 there were 1200 inmates enrolled in the various classes with 23 inmates earning their GED.

SUBJECT: Approve an amendment to Agreement 24129 with Visalia Unified School District.

DATE: June 7, 2011.

FISCAL IMPACT/FINANCING:

This contract is not to exceed \$295,000 for fiscal year 2011/2012. Funds paid to Visalia Unified School District represent salaries, benefits, GED testing, and material costs for the program. Expenditures will be made out of the Detentions budget. The Inmate Welfare Trust Fund will reimburse the General Fund for this expenditure. The funds will then be reimbursed through the Visalia Unified School District when they receive Average Daily Attendance (ADA) funds from the State. Funds are included in the Sheriff's Department's 2011/2012 operating budget. There will be no net county cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

This agreement is in alignment with the Quality of Life initiative of the Strategic Business Plan to encourage quality education opportunities.


