## REQUEST(S):

#### **SUMMARY:**

The Tulare County Library has operated with seven (7) professional librarians for at least 25 years. The dedicated professional and para-professional staff of the Library has successfully struggled with the dearth of professional staff and done an outstanding job of changing and expanding library services to meet the ever changing reading and informational needs of the public. However, the public needs and demands for quality public library service have never been higher and can best be met with additional librarians. Because of other public libraries budget woes, there is, at this time a plethora of energetic new and newer public librarians who are looking for work. By adding additional librarians the Tulare County Public Library will be able to offer increased services, new programs, and greater engagement with the

> community at a time when it is needed most. The cost of the new positions will be minimal as the library will be requesting the elimination of 2.5 vacant positions as part of the FY 2011 - 2012 budget proposal. The increased staffing will allow us to start a young adult program, improve public service delivery, increase computer classes, use social networking tools to allow the public more points of access to our services, and concentrate more on improving branch services.

## FISCAL IMPACT/FINANCING:

There is no cost to the General Fund.

The additional cost to the Library Budget for Fiscal Year 2010 - 2011 is \$ 4,500. The cost is more than offset by salary savings and can be absorbed by the Library budget.

The additional cost to the Library Budget for Fiscal Year 2011 – 2012 is \$17,000.

# LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative, which seeks to promote educational opportunities and to increase literacy countywide.
