SUBJECT:

Budget Adjustment to the Fiscal Year 2010/2011 budget to recognize staff charges for Community Development projects

REQUEST(S):

That the Board of Directors:

Approve adjustments to the Fiscal Year 2010/2011 budget to recognize staff charges for Community Development projects per the attached AUD 308 form (4/5ths vote required).

SUMMARY:

The Tulare County Redevelopment Agency (TCRA) employees provide assistance to Tulare County communities that are not within established Redevelopment project areas. Staff charges were incorrectly budgeted in Operations Transfer instead of Program Administration. A budget adjustment is necessary to correctly adjust staff charges.

FISCAL IMPACT/FINANCING:

The budget adjustment will result in no net County cost to the General Fund.
