#### SUBJECT:

Approve an Agreement with United States Department of Justice, Drug Enforcement Administration (DEA)

### REQUEST(S):

That the Board of Supervisors:

- 1. Approve an Agreement with United States Department of Justice, Drug Enforcement Administration (DEA), retroactive to January 1, 2011, and extending through December 31, 2011, in the amount of \$200,000. The revised agreement was just received; therefore, it must be handled retroactively.
- 2. Find that the Board had authority to enter into the proposed Agreement as of January 1, 2011, and that it was in the County's best interest to enter into the Agreement on that date.
- 3. Authorize the Chairman of the Board to sign four copies of the Agreement.

#### SUMMARY:

On May 3, 2011, your Board approved an agreement with the United States Department of Justice, Drug Enforcement Administration (DEA), which provides \$200,000 in funding for the Tulare County Sheriff's Department to provide staffing for the eradication of illicit marijuana. The DEA has since revised the agreement

that was signed on May 3, 2011. The revisions in the agreement are: 1) changing the words "Tulare County" to "Agency", 2) changing the funding code in the accounting classification/obligation under the heading "DEA Divisional Fiscal Clerk Must Input Into UFMS", and 3) adding the following two sentences "These federal funds shall only be used for the eradiation of illicit cannabis as provided in this agreement" and "These federal funds shall not be used to fund any state, county or local program that authorizes cultivating marijuana in support of that program".

The Department would like to note that this agreement deviates from the County's contract protocol in that parties may only terminate this agreement for cause upon thirty (30) days prior written notice to the other party.

## **FISCAL IMPACT/FINANCING:**

DEA funding for cannabis eradication and suppression funds for the 2011 calendar is \$200,000. Funds are included in the Sheriff Department's 2010/2011 budget and will be rolled over to the 2011/2012 budget as well. There is no net County cost.

# LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative to effectively and fairly investigate arrest, prosecute and punish individuals who engage in criminal behaviors. The Agreement will help fulfill this initiative by locating and eradicating illicit cannabis plants and in the investigation and prosecution of cases.

#### **ALTERNATIVES:**

The Board could choose not to approve this Agreement, but that is not recommended because without the efforts of the DEA funding, marijuana cultivation would continue to increase causing public and environmental safety hazards.
