SEVENTH AMENDMENT TO MEMORANDUM OF UNDERSTANDING AMONG THE SUPERIOR COURT OF CALIFORNIA, COUNTY OF TULARE, AND TULARE COUNTY SHERIFF'S DEPARTMENT

This Amendment To Memorandum Of Understanding (Agreement) No. 22231 is entered into as of July _____, 2011, with the SUPERIOR COURT OF CALIFORNIA (COURT), COUNTY OF TULARE SHERIFF'S DEPARTMENT (SHERIFF) and COUNTY OF TULARE (COUNTY). Henceforth within this Memorandum of Understanding (COUNTY AND SHERIFF) referred to as (SHERIFF).

RECITALS

WHEREAS, Parties entered into a Memorandum of Understanding No. 22231 dated March 8, 2005 for the provision of security services to the COURT; and

WHEREAS, COURT, and SHERIFF thereafter amended the existing Memorandum of Understanding on July 1, 2011; and

WHEREAS, COURT, and SHERIFF desire to amend the existing Amendment to Memorandum of Understanding to increase the rates of compensation, extend the term of the MOU, and update the Exhibits A through E;

THEREFORE, the parties hereto agree as follows:

1. Paragraph A "Initial Term;Option to Extend" of Section III. "Term of Agreement" of Tulare County Agreement No. 22231 is amended to read as follows:

The term of the Amendment shall commence effective July 1, 2011, and shall continue in effect through and terminate automatically on June 30, 2012. In the event the Governor's Realignment Proposal is passed by the Legislature, the COURT, SHERIFF and COUNTY will meet to discuss the impact of those sections of the MOU that are impacted.

2. Paragraph D "Rate of Compensation" of Section V. "Cost of Services/Compensation" of Tulare County Agreement No. 22231 is amended to read as follows:
For this agreement, COURT will compensate SHERIFF for provision of the basic

services an amount of \$5,171,948; as set forth in Exhibit B-1.

3. The previous Exhibit "A", "A-1", "B", "B-1", "C", "D", and "E" are hereby deleted and replaced in their entirety with the attached Exhibits A", "A-1", "B", "B-1", "C", "D", and "E", which exhibits are made part of the Agreement by reference.

Except as modified by this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.

THE PARTIES having read and considered the above provisions indicate their agreement by their authorized signatures below.
