Declaration of Intent to Vacate a Portion of Alta Lane In Wilsonia.

REQUEST(S):

That the Board of Supervisors:

- 1. Declare their intent to vacate a portion of Alta Lane in Wilsonia;
- 2. Set a public hearing for November 1, 2011 at 9:30 A.M. or thereafter, in the Board of Supervisors Chambers, 2800 W. Burrel Avenue, Visalia to consider the vacation of the aforementioned road; and
- 3. Direct the Resource Management Agency to publish and post the notice of public hearing in accordance with the Streets and Highways Code.

SUMMARY:

The portion of Alta Lane to be vacated is a 30 foot wide right of way, 166 feet in length located north of Brewer Lane in Wilsonia. Alta Lane was dedicated to Tulare County by the Mesa Addition to Wilsonia Map in 1921. The portion of Alta Lane to be vacated does not exist on the ground and is grown over with trees. It is bordered on the north by National Park land and was never intended to be a through road. Mr. John Wilson, owner of the parcels abutting Alta Lane on the east (APN-01-041-029) and west (APN 01-041-030), has requested by petition to vacate this portion of Alta Lane as he wishes to merge his parcels. No access to any parcels will be affected by this vacation. The County-wide Planning Branch of the Resource Management Agency has determined, through General Plan Referral 11-001 that the proposed vacation is not in conflict with the Tulare County General Plan.

SUBJECT: Declaration of Intent to Vacate a Portion of Alta Lane In Wilsonia.

DATE: September 13, 2011

FISCAL IMPACT/FINANCING:

There will be no net cost to the County General Fund as a result of this action. There will be no cost to the Road Fund as a result of this action.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

Strategic Initiative 1: Safety and Security includes the goal of improving and maintaining adequate transportation infrastructure. This action promotes that goal by redirecting maintenance activities from unneeded alignments to active roadways. Strategic Initiative 2: Economic Well Being includes the goal of encouraging growth consistent with the County General Plan. This action corresponds with that goal by allowing self determination of private property use.





TULARE COUNTY RESOURCE MANAGEMENT AGENCY STAFF REPORT GENERAL PLAN REFERRAL, GPR NO. 11-001 (VACATION OF ROAD)

PROPOSAL:

Request for vacation of a 166-foot portion of Alta Lane in Wilsonia.

LOCATION:

The section of road proposed to be vacated is 166 feet of Alta Lane above Brewer Lane. The road can be found in the northeast quarter of Section 5, Township 14 South, Range 28 East of the Mount Diablo Base & Meridian.

FACTS AND FINDINGS:

General Plan Elements: Redwood Mountain Plan (unadopted) 1.

> Land Use: Mountian Residential a.

b. Circulation: Not designated

Open Space: Mountain Residential c.

Urban Boundaries: Not within an Urban Bourndary

2. Zoning and Physical Use of the Land:

Alta Lane is a County right of way running in a south/north direction and intersects with Brewer Site:

Zoned A-1 (Agriculture) zone; contains mountain residential. Northside:

Westside: Zoned A-1 (Agriculture) zone; contains mountain residential.

Eastside: Zoned A-1 (Agriculture) zone; contains mountain residential.

Southside: Zoned A-1 (Agriculture) zone; contains mountain residential.

3. Flooding:

According to the Federal Emergency Management Agency (FEMA), National Flood Insurance Program (NFIP), Flood Insurance Rate Map (FIRM) for Community No. 06107C dated June 16, 2009; Panel No. 0150E, the road that is being vacated is located within Flood Zone X the area of 0.2% annual chance flood, areas of 1% chance of flood with average depths of less than 1 foot or with drainage areas less than 1 square mile, and areas protected by levees from 1% annual chance food. No new structures are proposed and there are no potential impacts from flood.

4. Agricultural Preserves:

The site is not within an agricultural preserve.

5. Access:

Access will not be eliminated or restricted to any parcel as a result of the vacation of this county right of way.

6. Public Utilities:


All rights-of-way and easements of record for public utilities are reserved and accepted pursuant to Section 8340 of the Streets and Highways Code.

CEQA REQUIREMENTS:

The Engineering Division of the Tulare County Resource Management, as the lead agency, will prepare the environmental documents under the provisions of the California Environmental Quality Act.

RECOMMENDATION:

Staff recommends that the Planning Branch Director find this GPR 11-001 is not in conflict with the Tulare County General Plan as amended.
