SUBJECT: Temporary Office Closure for the University of California

Cooperative Extension pursuant to Department Furlough Plan.

REQUEST(S):

That the Board of Supervisors:

Authorize the temporary office closure for the University of California Cooperative Extension Department from December 27 through December 30, 2011.

SUMMARY:

The University of California campuses and support units are closed the week of December 27 through December 30, 2011. University Staff are required to take annual leave during this period. The department has only two of nine county staff positions that are not participants in the current furlough program. The department requests the continuance of the program implemented in FY 2009-10 and in 2010-11. The office closure will occur during the holiday period when customer service requirements are historically minimal.

In order for a County Office to close on a particular day, other than those already fixed by County resolution or ordinance, the Board of Supervisors must adopt a resolution or ordinance setting out the dates the office will be closed.

Furlough savings are budgeted in the Fiscal Year 2011/12 budget. Temporary office closure will provide energy savings and additional operational savings.
