Approve a Waiver of the Tulare County Venue Requirement in a

Contract with Software Vendor G -2 Solutions

REQUEST(S):

That the Board of Supervisors:

Waive the standard venue requirement of Tulare County for the Contract with G-2 Solutions.

SUMMARY:

As part of the pre-employment background process the County fingerprints the prospective employees to obtain their criminal background from the Department of Justice (DOJ). This process is commonly referred to as a Livescan because the fingerprints are scanned and transmitted to DOJ. The vendor which Human Resources & Development(HRD) has previously utilized no longer provides this service and HRD, with assistance from IT and Purchasing, has gone through a process of negotiating a contract with a new vendor. The contract with the vendor requires the jurisdiction for any disputes be identified as Solano County, rather than Tulare County, which is a change from County contract protocols. Given the nominal risk associated with this agreement, it is requested the County's venue requirement be waived.

FISCAL IMPACT/FINANCING:

Costs for the Livescans has been included in the 2011-12 budget.
