To change ending date of the grant award from September 30, 2012, to June 30, 2013, and

Effective January 1, 2012:

Increase 11RSAT funds by \$122,507 from \$0 to \$122,507;

Increase 11RSAT match by \$40,836 from \$0 to \$40,836;


Increase the Total Project Cost by \$163,343 from \$369,991 to \$533,332;

This grant has the following special conditions:

- 08RSAT must be expended by March 31, 2012, and a 2-201 for these funds must be submitted by April 30, 2012, this reduces the liquidation period to zero days;
- 10RSAT must be expended by March 31, 2013, and a 2-201 for these funds must be submitted by May 31, 2013, this reduces the liquidation period to 30 days;

All other provisions of this agreement shall remain as previously agreed upon.
