SUMMARY:

In March 2012 the Tax Collectors office went out for RFP for the printing and mailing of the tax bills and notices. It is the Tax Collectors goal to stream line the printing and mailing process while getting the best rates possible for the services.

Upon review of the companies that responded, The Data Center., LLC was chosen.

FISCAL IMPACT/FINANCING:

The contract cost is not to exceed \$142,000 is included in 2012-2013 tax collector budget.
