**SUBJECT:** Approve an amendment to Agreement 22690 with Cutler-Orosi Unified School District.

**REQUEST(S):**

That the Board of Supervisors:

1. Approve an amendment to Agreement 22690 with Cutler-Orosi Unified School District, retroactive to July 1, 2012 and extending through June 30, 2013 for providing a school resource officer on district campuses. The amendment to Agreement 22690 is retroactive due to a delay in the Cutler-Orosi School board approving the amendment because of the summer break in their meeting schedule.
2. Find that the Board had the authority to enter into the proposed amendment to Agreement 22690 as of July 1, 2012, and that it was in the County's best interest to enter into the agreement on that date.
3. Authorize the Chairman to sign four copies of the amendment to Agreement 22690.

**SUMMARY:**

Cutler-Orosi Unified School District is seeking to continue to partner with the Sheriff's Department to provide a Sheriff's deputy to serve as a school resource officer on district campuses.

Under the contract, the deputy provides a visible law enforcement presence on campus; assists school officials in enforcing school attendance laws; utilizes

intervention and prevention skills with students who are involved in criminal activity; acts as a resource deputy for school personnel; and provides classroom instruction on law enforcement issues, such as gang awareness.

A prior agreement, identical except for the time period and amount was approved as to form by County Counsel on March 3, 2009. There were no deviations from the County contract protocol included in the prior agenda item. The proposed renewal agreement does not include any deviations from the County contract protocol.

**FISCAL IMPACT/FINANCING:**

The Sheriff's Department will be compensated \$79,740 by Cutler-Orosi Unified School District for the salary, benefits, and operating costs for the school resource officer. Funds are included in the Sheriff's Fiscal Year 2012/2013 budget. There is no net County cost.

**LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The County's five-year strategic plan includes Initiative 1: Safety and Security and Initiative 2: Quality of Life. This agreement supports these initiatives by collaborating with school districts, cities and community-based nonprofit organizations to promote early intervention for at-risk youth; and by encouraging innovative provision of quality supportive services for at-risk youth.
