Approve grant award agreement with Board of State and Community Corrections and approve capital asset purchase

#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve grant award agreement with the Board of State and Community Corrections for \$331,546 to operate the South Valley Marijuana Suppression Program, retroactive to October 1, 2012 through September 30, 2013. This request is retroactive because contract documents were only recently made available.
- 2. Authorize the Chairman to sign four copies of the grant award agreement.
- 3. Find that the Board had authority to enter into the proposed agreement as of October 1, 2012, and that it was in the County's best interest to enter into the agreement on that date.
- 4. Approve the capital asset purchase of a Remington Eyeball R1 surveillance system in the amount not to exceed \$6,775.
- 5. Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

#### **SUMMARY**:

The Sheriff's Department has led the South Valley Marijuana Suppression program with state funding since 2010. The task force has been responsible for the arrest

and prosecution of numerous illegal marijuana cultivators and traffickers in Tulare and Fresno counties.

The Marijuana Suppression grant program was originally administered by the California Emergency Management Agency. However, the new Board of State and Community Corrections (BSCC) took over the administration of ADA for the FY 2012-13 funding year.

On December 11, 2012, your Board approved the application for FY 2013 funding and operational agreement for the South Valley Marijuana Suppression Program.

The grant will be used to fund investigation and prosecution of illegal marijuana cultivators and traffickers in Tulare and Fresno counties. To facilitate those investigations, a portion of the grant will be used to purchase of a Remington Eyeball R1 surveillance system.

#### FISCAL IMPACT/FINANCING:

The Sheriff's Department, which is the fiscal agent for the \$331,546 grant, is incorporating the award into its FY 2012-13 operating budget, per the attached AUD 308. The District Attorney's Office has incorporated its share, \$35,807, of the grant into its FY 2012-13 operating budget. No matching funds are required for this grant.

### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The Tulare County Strategic Business Plan includes a Security and Safety Initiative. The South Valley Marijuana Suppression Program is consistent with the initiative by investigating and prosecuting illegal marijuana cultivators and traffickers.
