Approval of an amendment to Agreement No. 25619 with Star View

Adolescent Center.

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an amendment to Agreement No. 25619 with Star View Adolescent Center to provide residential treatment and an array of specialty mental health services, and add Therapeutic Behavioral Services (TBS). Star View Adolescent Center also provides twenty-four hour psychiatric treatment at the Psychiatric Health Facility (PHF) for children and adolescents between the ages of twelve (12) and seventeen (17) years of age. The amended amount shall not exceed \$160,000 (the maximum amount of the total agreement not to exceed \$280,000) retroactive to July 24, 2012 through June 30, 2013. This amendment is retroactive due to inadvertent delays in obtaining authorized signatures from contractor. It was impracticable for the Board to take action prior to July 24, 2012 due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had authority to enter into the proposed amendment as of July 24, 2012 and that it was in the County's best interest to enter into the amendment on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the amendment.

SUBJECT: Approval of an amendment to Agreement No. 25619 with Star View

Adolescent Center.

DATE: March 5, 2013

Adolescent Center to provide residential treatment and an array of specialty mental health services, inclusive of TBS, as well as twenty-four hour psychiatric treatment at the PHF for children and adolescents between the ages of twelve (12) and seventeen (17) years of age.

Star View Adolescent Center is the highest level of care for youth who are conserved and are unable to be maintained in any other lower level group homes in California.

Through this amendment with Star View Adolescent Center, approximately (1) consumer will be served for Fiscal Year 2012/2013. The purpose of this amendment is to update Exhibits A and B; Fiscal Year 2012/2013 is being increased by \$160,000 from \$120,000 to \$280,000 to provide for continued program services, and add Therapeutic Behavioral Services through the remainder of the fiscal year.

FISCAL IMPACT/FINANCING:

The maximum reimbursement for this amendment is \$280,000; which is included in the Fiscal Year 2012/2013 budget and is reimbursed through Medi-Cal revenues. No Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This amendment increases the ability to fulfill that obligation.
