SUBJECT: Approve vehicle budget adjustment.

REQUEST(S):

That the Board of Supervisors:

1. Approve the budget adjustment for the purchase of a budgeted vehicle as shown on the attached AUD 308 form (4/5ths vote required).

SUMMARY:

The Aud 308 budget adjustment requests that \$19,000 be transferred from the Agricultural Commissioner's Fiscal Year 2012/2013 budget for object #2200-Special Department Expense to object #7103-Trucks, for the purpose of purchasing a budgeted vehicle. The budgeted amount in 7103-Trucks was insufficient to cover the budgeted vehicles because of higher costs associated with the purchase of 4 Fusion Sedans which were purchased for their ability to get better fuel economy.

FISCAL IMPACT/FINANCING:

The amount requested is already in the Fiscal Year 2012/2013 budget for the Agricultural Commissioner. No additional net county costs will be incurred.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Economic Well-Being Initiative to promote economic development opportunities, effective growth management and a quality standard of living.
