### REQUEST(S):

That the Board of Supervisors:

- 1. Approve an amendment to Lease Agreement No. 21942 with John F. George and Donna Taber George to extend the term of the lease agreement for five years, to commence upon approval by the Board of Supervisors, for use of office space located at 26644 S. Mooney Blvd, Building A, Visalia, CA.
- 2. Authorize the Chairman to sign the amendment to Lease Agreement

#### **SUMMARY:**

Tulare County entered into Agreement No. 21942 with John and Donna George on May 18, 2004 to lease office space at 26644 S. Mooney Blvd., Building A, Visalia, CA. This agreement had a five year term. This building has been used by the Health and Human Services Agency (HHSA) since July 2004. In February 2008, the lease went into holdover status and in December 2008 an amendment was generated to extend the term an additional five years in exchange for a new roof. This lease will expire in May 2013.

The Lessor has requested to have this lease, plus two additional leases at 26644 S. Mooney Blvd., extended for five years and terminate on the same date. This has been requested by their financial institution in order to obtain favorable rates. In lieu of extending the term on the agreements, the parties have agreed to extend the term of the lease for five years from the date of Board of Supervisors approval; add

two, three year options to renew; and to modify the annual rent adjustment language to suspend the annual rental adjustment through December 31, 2015. The rent will be adjusted annually by 2% effective January 1, 2016.

HHSA desires to continue leasing the 1,500 sq. ft. of office space. The monthly rental rate of \$2,191.93 will remain through December 31, 2015 as the 2% annual rental adjustment will be suspended and then re-established on January 1, 2016.

#### FISCAL IMPACT/FINANCING:

The lease agreement's dollar amount will remain at \$2,191.93 per month (\$26,303.16 annually/\$1.46 square foot) plus utilities, telephone and custodial services for the 1,500 square feet of office space. The Lessor will provide all maintenance. Charges will be paid from budget account lines: 001-142-4030-2180 (60%), and 001-142-4032-2180 (40%). Reimbursement for costs will be provided by State and Federal allocations. No additional net costs to County.

#### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's Strategic Business Plan includes the Quality of Life Initiative to promote public health and welfare. Board approval of the amendment to agreement will help fulfill this initiative by ensuring supportive services for Health and Human Services clients located in Tulare County.
