SUBJECT: Accept Tulare County Indian Gaming Grant

REQUEST(S):

That the Board of Supervisors:

1. Accept grant funding in the amount of \$30,906 from the Tulare County Indian Gaming Local Community Benefit Committee.

SUMMARY:

The Tulare County Fire Department has applied for and been awarded a Tulare County Indian Gaming Local Committee (IGLCBC) grant to replace well-worn personal protective equipment (PPE) for firefighting personnel at the following stations; Strathmore, West Olive, Doyle Colony, Terra Bella, and Springville. The grant has been approved in the amount of \$30,906.

This PPE purchase will partially offset the direct impacts of the Indian Gaming activities at Eagle Mountain Casino that will be used during emergency responses to the Reservation/Indian Casino area.

The board previously authorized the submittal of the grant application on April 2, 2013, through resolution No. 2013-0182. It should be noted that the original grant request was in the amount of \$74,394; however on May 22, 2013 the IGLCBC awarded only \$30,906.

FISCAL IMPACT/FINANCING:

The grant award is \$30,906, with no match funding required, and will be paid during
