REQUEST(S):

That the Board of Supervisors:

- 1. Approve an agreement with Corizon Health, Inc., d.b.a. Corizon, to provide Comprehensive Health and Mental Health Care Services for the Tulare County Criminal Justice facilities from July 1, 2013 through June 30, 2016 for an amount not to exceed \$9,352,904, for the fiscal year from July 1, 2013 through June 30, 2014, \$9,855,789, for the fiscal year from July 1, 2014 through June 30, 2015, and \$10,151,463, for the fiscal year from July 1, 2015 through June 30, 2016;
- 2. Authorize the Chairman of the Board to sign three (3) copies of the Agreement;
- 3. Approve the attached Personnel Resolution:

SUMMARY:

The Health and Human Services Agency (HHSA) is responsible for providing comprehensive health and mental health services for all inmates and juveniles housed in the Tulare County Criminal Justice facilities. With the jail population at maximum capacity for the past five years, the demand for health-related treatment and pharmaceutical management has steadily increased. Concomitantly, inmates with chronic health conditions, complex mental health diagnoses, higher acuity levels associated with frequently untreated maladies, and increased lengths of stay have necessitated increasingly complicated treatment protocols. All providers charged with routine and specialty care of inmates have been taxed by the demands associated with their management. Moreover, the recent transfer of many inmates from the care of the State to local jurisdictions due to the passage of new legislation, including AB 109, has further challenged the traditional repertoire of interventions associated with the provision of medical and clinical treatment.

In order to ensure mandates imposed by State and Federal law are met in a timely and efficient manner, HHSA, Tulare County Sheriff's Office, Probation Department, and the County Administrative Office released a Request for Proposal (RFP) for the health and mental health care for adults and juveniles housed in the Tulare County Criminal Justice facilities. The County received proposals from three (3) respondents. Two proposals (2) included coverage for comprehensive health and mental health care; one (1) proposal included coverage for mental health care.

A preliminary committee representing four departments reviewed and ranked each proposal according to content compliance, ability to provide services, organizational

structure, and cost. A second committee interviewed the top two vendors. By unanimous decision, Corizon was selected by both committees as the organization best suited to meet the health care needs of both adult and juvenile populations. Extensive experience in the provision of services within correctional facilities and disciplinary expertise in the management of inmate populations will better ensure Tulare County's compliance with current and evolving State and Federal mandates. The County anticipates an initial contract term of three (3) years with the option to extend for an additional one-year period. While this Agreement is not anticipated to result in cost savings, it is expected to result in better and more timely service.

The Board of Supervisors has the authority under Government Code section 31000 to contract for specialized services in medical services, such as the services Corizon intends to provide to the County.

We would like to bring to the Board's attention the following items that deviate from the County Contract Protocol: 1) this agreement is for multiple years, 2) the agreement may be terminated by either party upon 180 days prior written notice, and 3) the agreement calls for mutual indemnification.

Advanced notice, including a copy of the RFP document, was provided to the representatives of the affected bargaining units before the RFP was released. The bargaining units were notified of the staff decision to bring this matter before the Board for approval. Subsequently, authorized representatives for the County and SEIU have been meeting and conferring regarding the impact. The attached Personnel Resolution outlines the impact to the HHSA position allocations, which was also provided to the appropriate union representatives. There are a total of 58 positions being deleted.

By operation of the language in the RFP, all proposals submitted in response to this RFP, including the proposal submitted by Corizon, will expire on July 1, 2013. Furthermore, any further delay by the Board to enter into the agreement with Corizon would undermine the County's ability to continue to comply with existing and evolving State and Federal mandates concerning the provision of medical and clinical treatment to persons housed within the jails and juvenile facilities.

If negotiations with SEIU are not completed by the time of adoption of the accompanying Board resolution authorizing the agreement with Corizon, the County will continue to meet and confer in good faith with SEIU.

FISCAL IMPACT/FINANCING:

The County General Fund dollars that the Agency receives will be sufficient to cover the costs of the contract.

WHEREAS, the County of Tulare must provide humane conditions of confinement, including but not limited to ensuring those designated to its care and custody receive, among other things, adequate medical care;

WHEREAS, the County of Tulare's Health and Human Services Agency is responsible for providing Comprehensive Health and Mental Health Care Services in the Tulare County jails and juvenile facilities;

WHEREAS, inmates with chronic health conditions, complex mental health diagnoses, higher acuity levels associated with frequently untreated maladies, and increased lengths of stay have necessitated increasingly complicated treatment protocols. All providers charged with routine and specialty care of inmates have been taxed by the demands associated with their management;

WHEREAS, the recent transfer of many inmates from the care of the State to local jurisdictions pursuant to AB 109 has further challenged the traditional repertoire of interventions associated with the provision of medical and clinical treatment;

WHEREAS, the Affordable Care Act requires the expansion of health care coverage and health care services for all persons, including those housed within the Tulare County jails and juvenile facilities, thus changing the landscape of health and mental health services that must be provided to those individuals;

WHEREAS, the County of Tulare desires to provide a higher level of services commensurate with the standards for accreditation by the Institute for Medical Quality (IMQ) and to ensure that mandates imposed by the State and Federal government are met in a timely and efficient manner;

WHEREAS, the County of Tulare's Purchasing Department released a Request for Proposal on January 30, 2013, soliciting proposals for the provision of health and mental health services in its jail and juvenile facilities;

WHEREAS, on January 18, 2013, the County of Tulare provided advanced notice to the Service Employees International Union, Local 521 (SEIU) of its intent to issue a Request for Proposal for health and mental health services in its jails and juvenile facilities, and the County of Tulare met with SEIU on February 13, 2013, regarding the impacts of the Request for Proposal;

WHEREAS, two reviewing committees represented by four County Departments selected Corizon Health, Inc. as the company best suited to provide the services needed by the County of Tulare due to its extensive experience in the provision of services within correctional facilities and disciplinary expertise in the management of inmate populations such that it would better ensure County of Tulare's compliance with current and evolving State and Federal mandates, including but not limited to Title 15, AB 109, and the Affordable Care Act, while also allowing the County of Tulare to meet IMQ health care standards;

WHEREAS, on May 1, 2013, the County of Tulare provided notice to SEIU of the recommendation to award the contract to Corizon Health, Inc., and the County of Tulare has met and conferred with SEIU on May 1, May 13, and June 3, 2013 and continues to meet and confer regarding the impacts of said contract in accordance with its Memorandum of Understanding with SEIU and the Meyers-Millias-Brown Act (MMBA);

WHEREAS, on May 17, 2013, SEIU requested the County of Tulare meet and confer over the decision to award the contract to Corizon Health, Inc. and continue to meet and confer over the impacts of said decision;

WHEREAS, Article 2 of the Memorandum of Understanding with SEIU expressly reserves to the County of Tulare the right to operate and direct the affairs of the County in all of its various aspects, including, but not limited to the right to determine whether services should be contracted for;

WHEREAS, the Board of Supervisors has the authority under Government Code section 31000 to contract for specialized services, including medical services;

WHEREAS, the Board of Supervisors finds that this Agreement will result in better and timelier medical and mental health services to persons housed within the jails and juvenile facilities and will ensure the County of Tulare's continued compliance with current and evolving State and Federal mandates as they apply to medical and mental health services within its jails and juvenile facilities;

WHEREAS, by operation of the language of the RFP, all proposals submitted in response to the RFP will expire on July 1, 2013;

WHEREAS, the Board of Supervisors finds that any delay in entering into the agreement with Corizon Health, Inc. would undermine the County's ability to continue to comply with existing and evolving State and Federal mandates concerning the provision of medical and clinical treatment to persons housed in the jails and juvenile facilities.
