#### SUBJECT:

Approve an amendment to Agreement No. 25084 with Family Preservation Community Services for the provision of Wraparound Services.

#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve an amendment to Agreement No. 25084 with Family Preservation Community Services for the provision of Wraparound Services, to extend the Agreement through June 30, 2014 and increase the Agreement amount by \$1,000,000 for the 2013/2014 fiscal year, effective retroactively to July 1, 2013. This amendment is retroactive due to inadvertent delays in obtaining authorized signatures. It was impracticable for the Board to take action prior to July 1, 2013 due to the time needed to process, prepare, and submit the agenda item;
- 2. Approve an amendment to Agreement No. 25084 with Family Preservation Community Services to add Exhibit B-1 to the Agreement retroactively to July 1, 2012. The addition of Exhibit B-1 is retroactive to July 1, 2012 due to a clerical error on the previous amendment. It was impracticable for the Board to take action prior to July 1, 2012 due to the nature of the error;

Find that the Board had authority to enter into the proposed amendment to extend the agreement and increase the dollar amount as of July 1, 2013, and to add Exhibit B-1 as of July 1, 2012, and that it was in the County's best interest to enter into the amendment and include the additions on those dates; and

#### **SUMMARY:**

Senate Bill 163, Chapter 795, Statutes of 1997, provided for the establishment of a statewide project entitled Wraparound. Wraparound provides services to families with multiple, complex needs that may threaten the families' stability and well-being, and the ability to keep their children safely at home. In 2001, the statutes were amended and Wraparound became a permanent State funded program. At that time all California counties became eligible to apply for wraparound funding.

Wraparound is a family-centered, strength-based, needs-driven planning process for creating individualized services and supports for children and their families. This allows counties the flexible use of State foster care funds to provide eligible children with family-based service alternatives to group home care using Wraparound as the service alternative.

On November 14, 2006, the Board of Supervisors authorized HHSA to submit the Tulare County Wraparound Implementation Plan to the California State Department of Social Services (CDSS) for approval. On January 31, 2007 the Tulare County Wraparound Implementation Plan was approved by CDSS. On February 12, 2008, the Board of Supervisors awarded the first RFP and agreement for the provision of Wraparound Services. On June 28, 2011, the Board of Supervisors for the second time awarded the RFP and agreement for the provision of Wraparound Services.

Family Preservation Community Services has demonstrated the capacity and operational ability to implement Wraparound Services as outlined in the Wraparound plan. The purpose of this amendment is to extend the term of the agreement to June 30, 2014.

#### FISCAL IMPACT/FINANCING:

No fiscal impact, funding for Wraparound is included in the Fiscal Year 2012/2013 budget. Wraparound is a cost neutral program of redirected Foster Care funding. No Net County Cost.

### **LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

Wraparound services provided through this amendment assist the County in meeting its five-year strategic plan's Quality of Life and Safety and Security Initiatives. Wraparound provides services and supports for high-risk children and their families so that they can have a permanent and stable home in Tulare County. This amendment increases the ability to fulfill that obligation.
