SUBJECT: Approve an amendment to Agreement No. 26177 with United States Department of Justice, Drug Enforcement Administration

REQUEST(S):
That the Board of Supervisors:

1. Approve an amendment to Agreement No. 26177 with United States Department of Justice, Drug Enforcement Administration, increasing the funding from \$220,000 to \$240,000 for cannabis eradication and suppression.
2. Authorize the Chairman of the Board to sign four copies of the amendment to Agreement No 26177.

SUMMARY:
On July 9, 2013, your Board approved an agreement with the United States Department of Justice, Drug Enforcement Administration (DEA), allocating \$220,000 in funding for the Tulare County Sheriff's Department to provide staffing for the eradication of illicit marijuana. This amendment to Agreement No. 26177 provides an additional \$20,000 in funding.
The funds are intended for payment of overtime for Sheriff's Deputies' while actively engaged in the cannabis eradication process, as well as, rental of equipment, fuel for vehicles and aircraft.
An original agreement was approved as to form by County Counsel and was approved by the Board of Supervisors on July 9, 2013. There were no deviations from the County contract protocol included in the original agenda item. The proposed amendment to agreement No. 26177 does not include any additional

deviations from the County contract protocol.

The only change from the original agreement, as amended to date, is a change to the dollar amount increasing from \$220,000 to \$240,000.

FISCAL IMPACT/FINANCING:

DEA funding for cannabis eradication and suppression for the 2013 calendar year is included in the Sheriff Department's 2013/2014 budget. There is no net County cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative to effectively and fairly investigate arrest, prosecute and punish individuals who engage in criminal behaviors. The agreement will help fulfill this initiative by locating and eradicating illicit cannabis plants and in the investigation and prosecution of cases.
