**SUBJECT:** Approve an Agreement with Tulare Youth Services Bureau, Inc.

**REQUEST(S):**

That the Board of Supervisors:

1. Approve an Agreement with Tulare Youth Services Bureau, Inc. for the provision of mental health services to Tulare County adolescents and children retroactive to July 1, 2013 through June 30, 2014. This agreement is paid through Medi-Cal; non Medi-Cal services may be reimbursed by the County up to \$250,000. This agreement is retroactive due to inadvertent delays in obtaining authorized signatures. It was impracticable for the Board to take action prior to July 1, 2013 due to the time needed to process, prepare, and submit the agenda item;
2. Find that the Board had authority to enter into the proposed agreement as of July 1, 2013 and that it was in the County's best interest to enter into the agreement on that date; and
3. Authorize the Chairman of the Board to sign three (3) copies of the agreement.

**SUMMARY:**

To ensure a greater quality of life, Tulare Youth Service Bureau, Inc. (TYSB) provides mental health rehabilitative, case management, and crisis intervention services to Tulare County children and adolescents. Tulare Youth Service Bureau, Inc. provides these services under the administrative oversight of Tulare County. It is estimated that over 2,000 clients will utilize the services of Tulare Youth Service

**DATE:** September 24, 2013

Bureau through this Agreement in Fiscal Year 2013/2014. This agreement is paid through Medi-Cal; non Medi-Cal services may be reimbursed by the County up to \$250,000. Tulare County is using Fiscal Year 2012-2013 Short Doyle Medi-Cal rates until the Fiscal Year 2013-2014 rate schedule has been finalized. Contract amendments may be necessary to reflect any updated rates.
