SUBJECT: Approve an agreement with the Porterville Unified School District.

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with the Porterville Unified School District to provide the services of Probation Officers for the continued operation of the Campus Probation Officer Program, retroactive to July 01, 2013 through June 30, 2014. This agreement is retroactive due to the date that the agreement was signed by the school district.
2. Find that the Board had authority to enter into the proposed agreement as of July 01, 2013 and that it was in the County's best interest to enter into the agreement on that date.
3. Authorize the Chairman of the Board of Supervisors to sign three copies of the agreement.

SUMMARY:

In December of 1993, the Board authorized the Chief Probation Officer to negotiate with other agencies of Tulare County to enter into a partnership to share the funding of the Campus Probation Officer Program. Under this program, Probation Officers are deployed to participating school districts to provide probation supervision within the said agencies. This program is partially funded by various school districts within the County. The Probation Department has had an established partnership and agreement with Porterville Unified School District for many years.

This agreement was approved as to form by County Counsel on September 09,

2013. This agreement deviates from County contract protocol as there is a 90-day advanced notice for termination without cause clause, and there is mutual indemnification.

FISCAL IMPACT/FINANCING:

There is no General Fund expense involved with this agreement. The cost per officer is \$74,214. Reimbursement per officer from the Porterville Unified School District is \$37,107. Some of the services provided in the program are eligible for reimbursement from Federal Title IV-E and Sales Tax Realignment funds. Estimated Title IV-E and Sales Tax Realignment reimbursement is \$37,107. The Probation Officer(s) position and revenue is included in the Tulare County Probation Department's Fiscal Year 2013/14 approved budget.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the provision for the safety and security of the public through collaboration with school districts, cities and community-based, non-profit organizations to promote early intervention for youth at risk. The approval of this agreement enables the Probation Officers assigned in this school district to continue with the monitoring of at-risk youth and the prevention of gang involvement and other criminal activities, which will result in a safer and more secure environment for the community.
