REQUEST(S):

That the Board of Supervisors:

Delete the following vacant positions in the Road Fund and General Fund that are no longer utilized. Road Fund: Two (2) Construction & Maintenance Worker II positions, No's 2620 and 2622; two (2) Engineering Aide II positions, No's 2536 and 2538; and, one (1) Deputy Assistant RMA Director-Public Works position, No. 9494. General Fund: One (1) Chief Planner position, No. 0285.

SUMMARY:

The Resource Management Agency has some long term vacancies that are not anticipated to be filled. Deletion of these positions will reduce budgeted salary costs and streamline the labor forecast for the Road Fund and the General Fund.

FISCAL IMPACT/FINANCING:

Deletion of these positions will reduce an annualized salary cost of \$226,340 from the Road Fund and \$79,234 from the General Fund
