Approve an amendment to Agreement No. 21234 with First 5 Tulare

County.

#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve an amendment to Agreement No. 21234 between Tulare County and First 5 Tulare County to extend the term of the agreement from July 1, 2014 to June 30, 2015 for support services and increase the annual General Accounting fee from \$1,410 to \$1,461.
- 2. Authorize Chairman to sign the amendment.

#### **SUMMARY:**

First 5 Tulare County was established to implement the objectives of Proposition 10 approved by voters in 1998. Through Agreement No. 21234, the Tulare County Auditor/Controller/Treasurer provides a variety of services to First 5 Tulare County. Some of the support services include general accounting, payment of claims and management of requests for payments, and accepting Commission funds from the State. The requested amendment would extend the term of the agreement for one year through June 30, 2015 and increase the annual General Accounting fee from \$1,410 to \$1,461.

The original agreement was approved as to form by County Counsel and was approved by the Board of Supervisors on June 18, 2002.

The only changes from the original agreement, as amended to date, are a change in time period.

**DATE:** June 17, 2014

#### **FISCAL IMPACT/FINANCING:**

First 5 Tulare County receives funds under Proposition 10, which increased the state surtax on cigarettes and other tobacco products. These funds are deposited in a trust fund under the control of the First 5 Tulare County. First 5 Tulare County reimburses the County for the cost of services received. There is no Net County Cost.

#### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative to promote strategies that ensures public health and welfare, educational opportunities, natural resource management and continued improvement of environmental quality. The First 5 Tulare County Agreement helps fulfill this initiative by ensuring that First 5 Tulare County funds are properly allocated.
