SUBJECT: Approval of agreement with Woodlake Unified School District.

REQUEST(S):

That the Board of Supervisors:

1. Approve an Agreement with Woodlake Unified School District, in an amount not to exceed \$205,894 for three (3) years, to provide direct skill training to high-risk parents from July 1, 2014 through June 30, 2017; and
2. Authorize the Chairman of the Board to sign three (3) copies of the Agreement.

SUMMARY:

Tulare County Health & Human Services Agency, Child Welfare Services (CWS) has contracted with Woodlake Unified School District to provide the SafeCare® programs since 2011. SafeCare® is a structured evidence-based home visitation program that provides direct skill training to high-risk parents. Providers teach families specific skills on how to manage child behavior, keep their home free of safety hazards, and take care of a child's basic health care needs. These models usually takes 18-20 sessions to complete (about 4-6 months), and may run longer if other services (i.e., case management) are also needed. SafeCare® is typically delivered in the home by trained staff carrying caseloads of approximately ten to twelve families at a time. Through this Agreement services will be provided to an estimated fifty (50) families annually.

Woodlake Unified School District will provide SafeCare® to parents who reside in

the Woodlake area. The targeted population will be primarily families referred by CWS through the Differential Response program. Differential Response is an early intervention program based on the concept that child safety is the mutual responsibility of communities and child welfare agencies. It is part of the State's child welfare re-design that is creating valuable connections among community agencies.

Expanding SafeCare® services in Tulare County has been a collaborative effort between Tulare County Health & Human Services Agency Child Welfare Services and Tulare County Mental Health along with the following participating agencies: Family Services of Tulare County, Parenting Network Inc., Lindsay Unified School District, Woodlake Unified School District, Cutler-Orosi Joint Unified School District, and Community Services and Employment Training.

We would like to bring to the Board's attention that the term of this Agreement is for multiple years which deviates from County Contract Protocol.

FISCAL IMPACT/FINANCING:

The contract is for a total of \$205,894 for three (3) years at \$66,312 for fiscal year 2014/2015, \$68,601 for fiscal year 2015/2016 and \$70,981 for fiscal year 2016/2017. This will be included in the Fiscal Year 2014/2015 through 2016/2017 budget. There is no county cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth, and children in state and federally mandated programs. This Agreement increases the ability to fulfill that obligation.
